The Dennis Moore Trophy is awarded annually to the club that, in the opinion of referees, has demonstrated the highest level of professionalism to the game of football

Each home team is allotted 50 points with away teams 35 points, and a point is deducted for each failure of the criteria as set out in the guidelines. After each game the referee e-mails the score to a central collator with every game being accounted for. Towards the end of the season two representatives from each of the leading three clubs are invited to attend the referees association "End of Season Dinner" where the winning club is presented with the

## HOME TEAM RESPONSIBILITIES

Did the home team ground marshal actually make himself / herself known to you before you requested the ground marshal to come forward to receive instructions??

Did you have to ask for the match ball?

Did you have to ask for the match fee?

Did you have to ask for the match card?

Was the original home team ground marshal whom you first met of suitable age?

## PAYMENT OF FEES

The match fee was not offered to you before the game started.

The match fee was not contained in an envelope.

The match fee was paid with coins.

The match fee was not actually handed to you, in a professional manner, or you had to go and collect it.

You had to ask for your match fee.

## PITCH

The nets needed adjustment of any kind (deduct an extra point if both nets at fault).

The lines could have been better marked.

The corner flags were not in place and you had to ask for them to be put in place.

Did your ground inspection reveal any other items requiring attention?

Any work, required to be done, on any items, was not made willingly, and with no complaints.

## HOME TEAM DUTIES

Did a home team official collect the match ball from you after the game?

Did a home team official collect the match card from you after the game?

Did the home team ground marshal co-operate if required?

The home team ground marshal did not appear to actually listen to your instructions or was uninterested or knew it all anyway.

Did the home team ground marshal move around the pitch amongst all spectators or remain stationary?

## AWAY TEAM DUTIES

The away team ground marshal was not readily available to you, when requested, to come forward to receive instructions.

There were problems in trying to find an away team ground marshal.

You were told that there was not anybody to be the away team ground marshal.

The away team ground marshal did not appear to actually listen to your instructions or was uninterested or knew it all anyway.

Did the away team ground marshal take action when required?

## APPROACH TO REFEREE

On arrival at the ground people did not talk to you and make you feel welcome and at ease or you were thought to be just an intruder.

The coach and/or team manager did not co-operate with your instructions either prior to commencement of, or during, the game.

The coach and/or team manager delayed the start of the first half of the game.

The coach and/or team manager delayed the start of the second half of the game.

Was interchange completed 100% correctly during the entire game?

## CROWD BEHAVIOUR (HOME TEAM)

You personally felt threatened by crowd behaviour.

The crowd acted aggressively towards you.

The crowd acted aggressively towards players of either side.

You needed to talk to the home team ground marshal re crowd behaviour of home side.

Any action required to be taken by the home team ground marshal was not effective.

## CROWD BEHAVIOUR (AWAY TEAM)

You personally felt threatened by crowd behaviour.

The crowd acted aggressively towards you.

The crowd acted aggressively towards players of either side.

You needed to talk to the home team ground marshal re crowd behaviour of away side.

Any action required to be taken by the away team ground marshal was not effective.

## BEHAVIOUR OF OFFICIALS/ ACCEPTANCE OF YOUR DECISIONS

(Deduct one point for each category of person involved)

(Minus points can be recorded in this category)

The team coach, team manager or team assistant coach questioned or commented on your decisions during the game.

Your decisions were not at all times readily accepted by any other team or club official.

Your decisions were not at all times readily accepted by the players.

Your decisions were not at all times readily accepted by the crowd.

The team coach, team assistant coach, team manager, any other team or club official or spectator approached you to question any of your decisions after the game

## AVAILABILITY OF CLUB ASSISTANT REFEREE

The coach did not readily accept your flag, or asked you to give the flag to someone else.

The coach had any problems in trying to find someone to run the line.

The person provided was not of suitable age (should be two years older than the age of the playing group).

The club assistant referee was not readily available to you, when requested, to come forward to be given instructions.

The club assistant referee did not appear to actually listen to your instructions or was uninterested or knew it all anyway.

## EFFICIENCY OF CLUB ASSISTANT REFEREE

The club assistant referee was not correctly positioned during the game, especially at the start of the game.

The club assistant referee did not appear to be correct with off side decisions.

The club assistant referee did not give you good and correct signals for throw-ins.

The club assistant referee did not give you good and correct signals for goal kicks.

The club assistant referee did not give you good and correct signals for corners.

## SPORTSMANSHIP OF PLAYERS

(Minus points can be recorded in this category)

Any player from their own team received a yellow card (deduct one point for each card).

Any player from their own team received a red card (deduct two points for each card).

Players did not willingly shake hands with the opposition players at the end of the game.

The players did not show, during the game, good sportsmanship to players from the opposition.

Was the sportsmanship of players exceptionally good? (Point to be deducted in ALL cases unless the sportsmanship of players was EXCEPTIONALLY good)
